We are hoping to fill the position with a qualified teacher to do 6th through 12th and possibly add another Paraprofessional. It has been very difficult in the past few years to find qualified teachers.

Federal IDEA Part-B and Preschool Narrative Renewal 2016-2019

Ms. Fortunato explained that every three years we are up for renewal to explain what we are using the IDEA funds for. Ms. Fortunato will submit the narrative to CDE and get this approved. We can submit during the open application if our needs change within those three years. IDEA funds are used for part of Ms. Schott, Ms. Fortunato and Ms. Denny's salary, paraprofessionals and also travel and special supplies for students. We try to carry-over 30% of the funds in case severe needs students move into either district.

MOE- Maintenance of Effort

We received notification that we have met our MOE. Ms. Fortunato and Ms. Schott explained that in general the MOE is Federal funds appropriated under Part B of IDEA that may only be utilized to cover the excess costs of providing special education and related services to students with disabilities. These Federal funds must supplement/increase the level of other Federal, State and local funds expended for special education and related services and in no case supplant these funds. In addition, IDEA includes separate maintenance of effort provisions that apply independently at the State and local levels.
